Section 4: First-aid Measures

Inhalation

Rescuers should put on appropriate protective gear. Remove from area of exposure. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Keep victim warm. Get immediate medical attention. To prevent aspiration, keep head below knees.

Eye Contact

Section 6: Accidental Release Measures

Spill and Leak Procedures

Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations.

Section 7: Handling and Storage

Handling Procedures

Keep out of reach of children. Keep container tightly closed.

Use with adequate ventilation. Avoid breathing dusts, mists, and vapors. Do not get in eyes, on skin, or on clothing. Wear eye protection and protective clothing.

Wash thoroughly after handling.

Storage Requirements

Store containers in a cool, dry, well ventilated place. Keep container closed when not in use. Store in fiberglass, polyethylene, or polypropylene containers. Do not store in metal containers, especially aluminum. Storage in certain metal containers at temperatures above 60°C / 140°F may result in hydrogen gas evolution.

Do not store at temperatures above 48°C / 120°F.
